Covid-19 Policies

Due to Covid-19 we ask that all families follow this policies. Please initial on lines, sign, date at bottom and return.

_____Please contact us immediately, if anyone in your household:

- Has tested positive for Covid-19.
- Showing symptoms of Covid-19.
- Is awaiting test results due to possible exposure to Covid-19
- Has been asked to isolate due to possible exposure to Covid-19

_____Children will not be allowed to come to Sugar & Spice Family Daycare if anyone in Household:

- Tested positive for Covid-19,
- Showing symptoms of Covid-19
- Exposed to a person who has tested positive Covid-19.
- Are told to self-isolate due to possible exposed to Covid-19.

_____When in doubt call Kim @ 908-938-0176 and I will go over Covid checklist with you and let you know if you children may come in to Sugar & Spice Family Daycare.

_____Your child will not be allowed to come back to Sugar & Spice Family Daycare until they are cleared to return to daycare by a doctor's note and/or health dept. clearance.

_____Failure to notify Sugar & Spice Family daycare in the case of positive test of Covid-19, or member of household asked to isolate due to possible exposure to Covid-19, will result in termination of care at Sugar & Spice Family Daycare.

_____Sugar & Spice Family Daycare will not have an open-door policy until further notice.

_____Masks are required when entering the house for all persons over the age of 2 years. If your child does not have a mask one will be provided. Additional masks maybe purchased from us.

_____Upon arrival and departure parents are asked ring the door bell. To limit the amount of possible exposure in the house. We will meet you at the door and ask that parents do not enter at this time. In the case of inclement weather you may enter the mudroom wearing a mask. Please use hand sanitizer upon entering and do not leave mudroom.

_____Each child's temperature will be taken upon arrival. Any child that has a temperature over 100 degrees, will not be permitted to stay. We will do a visual check to make sure you child(ren) do not appear to be ill. It will be at our discretion whether to send a child home at this time, out of abundance of caution to keep all Sugar & Spice children and families healthy. Your child must be fever free for 48 hours or have a doctor's note stating that they may return to daycare.

_____Do Not give fever reducing medicine before Daily temperature check.

_____While in our care, all the child(ren) temperatures will be taken twice-a-day with a no-touch thermometer and sanitized after each use. If your child develops a temperature while here, we ask that you leave work immediately and pick up your child. In the event we cannot reach you, we will call the emergency contact that is listed on file for your child.

_____If your child needs to go to doctor for any type of illness please bring us a note from the doctor that states they may return to Sugar & Spice Family Daycare.

_____No personal toys, diaper bags, blankets or other items that must travel home each day are permitted at this time. Please make sure we have extra clothes or other items that your child may need that can remain here.

_____Special attention to proper hand washing, coughing and sneezing etiquette is part of everyday lessons.

_____Jenni and I have continued to disinfect and sanitize multiple time a day, with extra attention given to toys, rest mats, cribs and all common touch points including bathroom, door handle, tables, chairs and other high touch areas.

_____We also spend as much time as possible outside, weather permitting. Please dress appropriate for outdoor play.

The safety and health of our children and families is always of the utmost importance to us, both Jenni and I have been tested negative for Covid-19. We will also follow polices.
